Dr. Francis testified that his sole concern for Ms. Gray and the children had been the safety of the children and that he had not conducted an individual physical examination of either Ms. Gray or the children, although he had seen and examined the children during surgery. The defendant merely notes in his brief to this Court that the plaintiffs presented no evidence concerning the state of the children's health. Defendant does not mention or question the testimony of Dr. Francis concerning the condition of the children or the health of Ms. Gray. He does not state whether he thinks that his negligence caused the children to be injured during surgery. Defendant does not state what was the alleged tortious conduct of the nurses or whether he thinks that

their alleged negligence caused the children to be injured during surgery. Finally, defendant *129 does not state whether the nurses' alleged negligence prevented him from being able to properly treat Ms. Gray and the children. These facts are not in the record and are not stated in the defendant's brief to this Court. The defendant has not given this Court a basis for deciding that his negligence caused Ms. Gray and the children to be injured during surgery.
